

REGULAR MEETING OF THE BURBANK CITY COUNCIL JANUARY 9, 2019

CALL TO ORDER	The meeting of January 9, 2019 was called to order at 7:30 PM by Alderman Robert Contreras in the Council Chambers at 6530 West 79 th Street Burbank, Il.

MOTION FOR TEMPORARY APPOINTMENT	Alderman Robert Contreras made a motion seconded by Alderman James Grider to appoint Alderman Jason Pyle as temporary Chair for the January 9, 2019 City Council meeting in the absence of Mayor Dan Foy.
