MAY 13, 2020

CALL TO ORDER

The meeting of May 13, 2020 was called to order at 7:30 PM by Mayor Dan M. Foy in the Council Chambers at 6530 West 79th Street Burbank, IL.

ROLL CALL

Chief Dave Gilgenberg II informed City Council that his Department has prepared an Incident Action Plan on mitigation during the pandemic and it has been distributed to Council and Department heads.

Mayor Foy stated that McDonald's held a First Responders Appreciation Day on May 13th which was very successful.

The Mayor also attended a presentation of PPE equipment to the Burbank Fire Department by the Cook County Board. President Toni Preckwinkle was in attendance along with members from Emergency Management and the Illinois National Guard.

The Mayor informed City Council that most summer City projects would be put on hold except for the re-surfacing project on 78th Street. These funds were previously allocated for the project and do not affect expenditures during this crisis.

Mayor Foy also informed the Council that the 50th Anniversary party for the City scheduled for the weekend of June 26th has been cancelled.

The Mayor stated that Tony's Finer Foods is holding a job fair this week and is committed to hire at least 250 employees from the Burbank area.

The City of Burbank wishes to extend its condolences to the family of Alderman Robert Contreras. The sister of Alderman Contreras' wife passed away out of state as a result of the corona virus.

There being no further business, the Chair asked for a motion to adjourn. The motion was made by Alderman Contreras and seconded by Alderman Haerr with unanimous voice approval and so declared by the Chair.
