CALL TO ORDER

The meeting of August 17, 2022 was called to order by Mayor Dan M. Foy at 7:30 PM in the Council Chambers at 6530 West 79th Street Burbank, Il.

**CITIZEN'S
REPORT**

The Chair recognized representatives from the Burbank American 15 year old baseball team who presented him with a replica team jersey and thanked the City for their support in their quest to make it to the Little League World Series. The Burbank American 15 year old and the Burbank National 13 year old team were crowned 2022 State Champions in the respective divisions. Burbank American fell short in the World Series playoffs after taking the Central Division and Burbank National's lost their final game in regionals which would have propelled them to a World Series playoff bid. Mayor Foy commended them on their success, as well as the way they represented the City of Burbank. Clerk Szymczak stated that in recognition of both teams, he designed a City Sticker for the 2023-2024 season honoring the teams as 2022 State Little League Champions.
