



**REGULAR MEETING

CALL TO ORDER

The meeting of October 26, 2022 was called to order by Mayor Dan M. Foy at 7:30 PM in the Council Chambers at 6530 West 79th Street Burbank, Il.

ROLL CALL

He also thanked Chief Jack Garcia for assisting in providing the "Bat Mobile" at the recent Burbank Park District Halloween Festival. Finally, the Mayor thanked Alderman Claude Haerr for his assistance in obtaining roof core samples at all the City facilities for a future roof replacement project. An outside company would have charged \$6,000.00 for that service. Alderman Haerr performed the service at no charge to the City.

Alderman Haerr made a motion seconded by Alderwoman Gagle to hire P.D. lateral candidate Marcin Stafira as patrol officer for the Burbank Police Department. A roll call indicated 6 Ayes and 0 Nays. Voting Aye: Alderwoman Gagle, Alderman Contreras, Alderwoman Gustafson, Alderman Haerr, Alderman Piznarski and Alderman Phillips. The candidate was sworn in by Fire-Police Commissioner Chris Wiest. Mayor Foy read a brief biography.

ADMINIS-

Mayor Foy asked that any Reavis High School students in attendance who needed their government class forms validated, could do so at the adjournment of the Council meeting.

Clerk Szymczak, with approval of Mayor Foy, asked for a moment of silence acknowledging the recent passing of retired Fire Chief Martin Kreil, who served the City for 47 years, and Charles Bandusky, a resident who rarely missed a Council meeting and always had "provocative" questions to ask.
