CALL TO ORDER

The meeting of April 26, 2023 was called to order by Mayor Dan M. Foy at 7:30 PM in the Council Chambers at 6530 West 79th Street Burbank, Il.

A roll call indicated 7 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald. Contreras, Ald. Gustafson, Ald. Haerr, Ald. Pacella, Ald. Piznarski and Ald. Phillips.

Alderman Haerr made a motion seconded by Alderswoman Gustafson to award Morton Salt as low bidder for the 2023 Bulk Rock Salt project in the amount of \$245,160.00 (\$81.72 per ton / 3000 ton order). A roll call indicated 7 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald. Contreras, Ald. Gustafson, Ald. Haerr, Ald. Pacella, Ald. Piznarski and Ald. Phillips.

Alderman Contreras made a motion seconded by Alderman Pacella to award Lindahl Brothers as low bidder for the 2023 Hot Mix Asphalt Program in the amount of \$48,750.00 (\$65.00 per ton / 750 tons proposed order). A roll call indicated 7 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald. Contreras, Ald. Gustafson, Ald. Haerr, Ald. Pacella, Ald. Piznarski and Ald. Phillips.

Alderswoman Gagle made a motion seconded by Alderman Haerr to approve the hiring of the following candidates as Patrol Officers to the Burbank Police Dept: Mateusz Krol, John Mologousis, Mark Nuemann and Julio Zapata. A roll call indicated 7 Aye and 0 Nays. Voting Aye: Ald. Gagle, Ald. Contreras, Ald. Gustafson, Ald. Haerr, Ald. Pacella, Ald. Piznarski and Ald. Phillips. The officers were sworn in by Fire-Police Commission Secretary Chris Wiest.

Alderman Phillips made a motion seconded by Alderswoman Gagle to award Artlow Systems the Fire Department Headquarters Apparatus Floor reconstruction project in the amount of \$54,692.90. A roll call indicated 7 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald. Contreras, Ald. Gustafson, Ald. Haerr, Ald. Pacella, Ald. Piznarski and Ald. Phillips.

Alderman Contreras made a motion seconded by Alderman Haerr to approve the sale of a 2008 Ford F 350 Super Duty Ambulance to S.E.T. Environmental in the amount of \$15,000.00 "AS IS." A roll call indicated 7 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald. Contreras, Ald. Gustafson, Ald. Haerr, Ald. Pacella, Ald. Piznarski and Ald. Phillips. Chief Gilgenberg thanked FF/PM Brad Zurek for being instrumental in the sale of the vehicle.
