

REGULAR MEETING OF THE BURBANK CITY COUNCIL NOVEMBER 8, 2023

CALL TO ORDER

The meeting of November 8, 2023 was called to order by Mayor Dan M. Foy at 7:30 PM in the Council Chambers at 6530 West 79th Street Burbank, Il.

ROLL CALL

A roll call by Clerk Szymczak indicated the following members present: Ald. Barb Gagle, Ald. Robert Contreras, Ald. Sheri Gustafson, Ald. Claude Haerr, Ald. Mitchell Piznarski, Ald. Thomas Phillips, Mayor Dan Foy, Clerk Barry J. Szymczak and Treasurer Dave Viverito. Absent: Ald. John Pacella. Also in attendance: City Attorney Vince Cainkar.

PLEDGE OF ALLEGIANCE

Mayor Foy asked all to rise for the Pledge of Allegiance.

JOURNAL

Mayor Foy asked for a motion to approve the minutes of October 25, 2023. The motion was made by Ald. Contreras and seconded by Ald. Gagle with unanimous approval by voice vote and so declared by the Chair.

ADMINIS-TRATION REPORT Mayor Foy filed the following report: The Shell Station at 79th & Cicero is in line to be demolished and rebuilt as a service station / convenience store projected for Spring 2024; the same will happen with the Burger King property at 79th St. east of Harlem which is going to be a coffee house, also projected for Spring 2024; the City is investigating complaints about the CVS property at 87th & Harlem in reference to upkeep and refuse. The property belongs to Bridgeview but affects Burbank residents in the area of 86th & Nottingham. Test planting will occur at the Melvina Reservoir in the Spring of 2024 to see what will grow before the City takes final control of the project. Finally, the Titan Football League has requested permission to run a "Queen of Hearts" raffle. The City will examine the parameters within state law.

CITY ENGINEER REPORT

City Engineer Geary reported RTU and Roof Units will be delivered next week and ready for installation. He also reported that the City has received an additional \$350,000.00 in grants for City Projects. Mayor Foy thanked Tim for his great work.

Ald. Contreras made a motion seconded by Ald. Gagle to ratify an agreement between the City of Burbank and the Illinois Council of Police representing the Burbank Police Sergeants. A roll call indicated 6 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald. Contreras, Ald. Gustafson, Ald. Haerr, Ald. Piznarski and Ald. Phillips.
