- CALL TO ORDER** The meeting of June 24, 2015 was called to order at 7:30 p.m. by Mayor Klein in the Council Chambers at 6530 W. 79th street in Burbank, Illinois.
- ROLL CALL** Roll call indicated the following Council members present: Alderman Szymczak, Grider, Pacella, Piznarski and Pyle. Also present: Mayor Klein, Treasurer Viverito, Clerk Roach and Attorney Vince Cainkar. Absent: Alderman Foy and Looney.
- The meeting opened with the pledge of allegiance to the flag.
- JOURNAL** Motion made by Alderman Grider seconded by Alderman Pacella to approve the minutes of June 10, 2015 as presented was unanimously approved by voice vote and so declared by the Chair.
