



REGULAR MEETING

BURBANK CITY COUNCIL
JUNE 8, 2016

CALL TO ORDER The meeting of June 8 was called to order at 7:30 p.m. by Mayor Klein in the Council Chambers at 6530 W. 79TH Street in Burbank, Illinois. Mayor Klein welcomed Clerk Roach back and said she was missed by all. Clerk Roach thanked him,.

ROLL CALL Roll call indicated the following Council members present: Alderman Foy, Looney, Szymczak, Grider, Pacella, Piznarski..and Pyle Also present, Mayor Klein, Clerk Roach and Attorney Cankar. Absent: Treasurer Viverito

The meeting opened with the pledge of allegiance to the flag.

JOURNAL Motion made by Alderman Grider seconded by Alderman Looney to approve the minutes of May 25, 2016 was unanimously approved by voice vote and so declared by the Chair .
