



REGULAR MEETING  
OF THE  
BURBANK CITY COUNCIL  
JANUARY 13, 2016

- CALL TO ORDER** The meeting of January 13, 2016 was called to order at 7:30 p.m. by Mayor Klein in the Council Chambers at 6530 W. 79<sup>TH</sup> Street in Burbank, Illinois
- ROLL CALL** Roll call indicated the following Council members present: Alderman Foy, Looney, Szymczak, Grider, Pacella, Piznarski and Pyle. Also present, Mayor Klein, Treasurer Viverito, Clerk Roach and Attorney Vince Cainkar.
- The meeting opened with the pledge of allegiance to the flag.
- JOURNAL** Motion made by Alderman Grider seconded by Alderman Looney to approve the minutes of December 16, 2015 as presented was unanimously approved by voice vote and so declared by the Chair.
- CURRENT BILLS** Motion made by Alderman Grider seconded by Alderman Szymczak, to approve the current list of bills. A roll call vote indicated 7 Ayes and 0 Nays. The Chair declared the motion carried. Voting Aye: Alderman Foy, Szymczak, Grider, Looney, Pacella, Piznarski and Pyle.
- NEW BUSINESS** Alderman Foy said he would like to mention that the Sea food restaurant in the old Bakers Square restaurant has all their permits and there is going to be a delay of at least a month and a half maybe two months. Mayor Klein told him that they did not renew their liquor license. He is in Mexico and his manager was supposed to renew it for him. Kathy had a number of conversations with her and she was supposed to come in the day before the end of the year and she never came in so there might not be any "margaritas" unless he grants him one.
- CITIZEN'S REPORTS** The Chair recognized Charles Bandusky of 8548 S. Lavergne, Burbank Illinois who wanted to know if we were going to do any of the streets Mayor Klein said we always work with Dan Lipinski to get some of these roads done and we are getting some money from IDOT so we will do what we can but it won't be till summer He said when we did 83<sup>rd</sup> st. it cost almost 3 million dollars and we don't have that kind of money. His next question was about Mayor Emmanuel of Chicago who said he was going to allow thousands of refugees into Chicago. He then said he thought Chicago was broke and Mayor Klein told him that was a question for the City Council in Chicago, not Burbank.
- MOTION TO ADJOURN** There being no further business to be brought before the City Council, the Chair asked for a motion to adjourn. The motion was made by Alderman Szymczak seconded by Alderman Looney to adjourn was agreed upon by voice vote and so declared by the Chair.
