- CALL TO ORDER** The meeting of January 25, 2017 was called to order at 7:30 P.M. by Mayor Klein in the Council Chambers at 6530 W. 79<sup>th</sup> street in Burbank , Illinois.
- ROLL CALL** **Roll call indicated the following Council members present:**  
Alderman Foy, Contreras, Szymczak, Grider, Pacella, and Piznarski.  
Also present: Mayor Klein, Treasurer Viverito, Clerk Roach and Attorney Vince Cainkar. Absent: Alderman Pyle.
- The meeting opened with the pledge of allegiance
- JOURNAL** Motion made by Alderman Grider seconded by Alderman Contreras to approve the minutes of January 11, 2017 as presented was unaminously approved by voice vote and so declared by the Chair.
- CURRENT LIST OF BILLS** Motion made by Alderman Grider seconded by Alderman Szymczak to approve the current list of bills. A roll call vote indicated six Ayes and 0 Nays. Voting Aye: Alderman Foy, Pacella, Grider, Piznarski Szymczak and Contreras.
- DEPT. OF ZONING** Alderman Foy made the motion to table Item 16-11-1 seconded by Alderman Contreras – Anthony Medrano 8510 S. Cicero, Burbank, Il., the petitioner is requesting a special use to convert an existing building to open a daycare center. Since he has not provided the building commissioner with the site plans; hence the motion to table. A roll call vote indicated six Ayes and 0 Nays to table the item. Voting Aye: Alderman Grider, Pacella, Foy, Szymczak. Piznarski, and Contreras. The Chair declared the motion carried.
- Alderman Foy made the motion seconded by Alderman Pacella to authorize the attorney to prepare an ordinance for Adam Bryja , 7952 S. Natoma , Burbank, Illinois. The petitioner is requesting a variation to install a 6' privacy fence on front yard side set back. Approved by Zoning. A roll call vote indicated 6 Ayes and 0 Nays. Voting Aye: Alderman Contreras, Pacella, Grider, Szymczak, Piznarski, and Foy. The Chair declared the motion carried.
- DEPT. OF ADMINISTRATION** Mayor Klein then invited the Reavis students in the audience to come up front after the meeting is adjourned and that anyone at the front table or the Council table could sign their government class papers.
