Mayor Foy reported that the Starbud's Cannabis Dispensary opened on Saturday January $7^{\text {th }}$.

Alderman Contreras made a motion seconded by Alderwoman Gustafson to approve payment to Fusus for a 5 -year agreement in video surveillance in the amount of $\$ 50,000.00$ per year. This agreement allows the City, with permission from anyone within the City such as the Park District, banks, businesses, etc., who already utilize surveillance, to tie into their systems for more efficient crime prevention. Alderman Haerr made a motion seconded by Alderman Piznarski to appoint Lt. Sean Moran as Commander of the Investigations Division of the Burbank Pofice Department. A roff call indicated 6 Ayes and 0 Nays. Voting Aye: Alderman Contreras, Alderwoman Gustafson, Alderman Haerr, Alderman Pacella, Alderman Piznarski and Alderman Phillips.

Alderman Haerr made a motion seconded by Alderman Contreras to promote Sgt. Guy Ott to the rank of Lieutenant with the Burbank Police Department. A roll call indicated 6 Ayes and 0 Nays. Voting Aye: Alderman Contreras, Alderwoman Gustafson, Alderman Haerr, Alderman Pacella, Alderman Piznarski and Alderman Phillips. The candidate was sworn in by Fire-Police Commission Secretary Chris Wiest. Mayor Foy read a brief biography.

Alderman Haerr made a motion seconded by Alderman Pacella to promote Sgt. Israel Rodriguez to the rank of Lieutenant with the Burbank Police Department. A roll call indicated 6 Ayes and 0 Nays. The candidate was sworn in by Fire-Police Commission Secretary Chris Wiest. Mayor Foy read a brief biography.
