A roll call indicated 6 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald Contreras, Ald. Haerr, Ald. Piznarski, Ald., Pacella and Ald. Phillips. Absent; Ald. Gustafson. Motion passed.

Ald. Haerr made a motion seconded by Ald. Gagle to authorize the purchase of a 2026 Ford Explorer for the Burbank Police Canine Unit Officer (Not to exceed \$42,000). A roll call indicated 6 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald Contreras, Ald. Haerr, Ald. Piznarski, Ald., Pacella and Ald. Phillips. Absent; Ald. Gustafson. Motion passed.

Ald. Pacella made a motion seconded by Ald. Gagle to authorize the purchase of (6) tasers, Model 10 for the Burbank Police Department (Not to exceed \$22,000). A roll call indicated 6 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald Contreras, Ald. Haerr, Ald. Piznarski, Ald., Pacella and Ald. Phillips. Absent; Ald. Gustafson. Motion passed.

Ald. Contreras made a motion seconded by Ald. Piznarski to authorize the purchase of a 2026 Ford F550 Duralift Bucket Truck for the Public Works Department (at a cost not to exceed \$210,000). A roll call indicated 6 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald Contreras, Ald. Haerr, Ald. Piznarski, Ald., Pacella and Ald. Phillips. Absent; Ald. Gustafson. Motion passed.

Ald. Gagle made a motion seconded by Ald. Phillips to approve the 2025 Collective Bargaining Agreement for the Burbank Police Department. A roll call indicated 6 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald Contreras, Ald. Haerr, Ald. Piznarski, Ald., Pacella and Ald. Phillips. Absent; Ald. Gustafson. Motion passed.

Ald. Gagle made a motion seconded by Ald. Contreras to make a motion to appoint Leutenant Guy Ott to the position of Commander for the Burbank Police Department. A roll call indicated 6 Ayes and 0 Nays. Voting Aye: Ald. Gagle, Ald Contreras, Ald. Haerr, Ald. Piznarski, Ald., Pacella and Ald. Phillips. Absent; Ald. Gustafson. Motion passed. Mayor Gilgenberg read a brief Bio. on Commander Ott.

CITIZENS REPORT

Resident – 7919 Major Ave. reported a concern with parking/safety issues on 80th Ave. Mayor Gilgenberg asked that the resident address their concerns with the Police Chief at the conclusion of the meeting.

Jason Taylor – 7702 Natchez Ave. reported a concern about stores with signs and merchandise blocking the store front windows. The mayor asked for a specific location. Mr. Taylor stated the strip mall between Central Ave. and Parkside. He also addressed a concern over produce being left in the parking lot of a business. Commissioner Hession was aware of the issues and stated that they would be resolved.

There being no further business, the Chair asked for a motion to adjourn. The motion was made by Alderman Contreras and seconded by Alderman Piznarski with unanimous approval and so declared by the Chair. The meeting was adjourned at 7:53 PM.
